Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; ALL that piece, parcel or lot of land with all buildings and improvements thereon, situate, lying and being on the southern side of Hicks Court in Greenville County, South Carolina, being known and designated as a major portion of Lot No. I on a plat of Ecole Acres, Section II, made by Campbell and Clarkson Surveyors, Inc., dated July 12, 1974, recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4-R, Page 90 and having, according to said plat, the following metes and bounds, to-wit:
