"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Dukeland Drive, near the City of Greenville, being shown as Lot No. 55 on a plat of DUKELAND PARK, made by Dalton & Neves in June, 1940, recorded in the RMC Office for Greenville County in Plat Book J at Page 221 and having the following metes and bounds, to-wit:

Beginning at a stake on the northwestern side of Dukeland Drive, corner of Lot No. 54 and running thence with the line of said Lot, N.35-42 W. 137 feet to a stake at Langston Creek; thence with the creek as the line, traverse of which is S.71-33 W. 52.3 feet to a stake at the corner of Lot No. 56; thence with the line of said Lot, S.35-42 E. 152.5 feet to a stake on Dukeland Drive; thence with the northwestern side of Dukeland Drive, N.54-18 E. 50 feet to the beginning corner.
