TO ALL WHOM THESE PRESENTS MAY CONCERN: Ray E. Ledford, Jr. and Grace B. Ledford

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -+ ----- Seven Thousand Five Hundred and No/100----- DOLLARS

(\$ 7,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ten years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Dukeland Drive, near the City of Greenville, being shown as Lot No. 55 on a plat of DUKELAND PARK, made by Dalton & Neves in June, 1940, recorded in the RMC Office for Greenville County in Plat Book J at Page 221 and having the following metes and bounds, to-wit:

Beginning at a stake on the northwestern side of Dukeland Drive, corner of Lot No. 54 and running thence with the line of said Lot, N.35-42 W. 137 feet to a stake at Langston Creek; thence with the creek as the line, traverse of which is S.71-33 W. 52.3 feet to a stake at the corner of Lot No. 56; thence with the line of said Lot, S.35-42 E. 152.5 feet to a stake on Dukeland Drive; thence with the northwestern side of Dukeland Drive, N.54-18 E. 50 feet to the beginning corner.

This is the same property as that conveyed to the mortgagors herein by deed from Shelby Jean Stockton recorded in the RMC Office for Greenville County on October 5, 1976.
