"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

"ALL that piece, parcel or lot of land in Chick Springs township, County of Greenville, State of South Carolina, located at the Southern intersection of Old U.S. Highway and Suber Road located near Greer, S.C. and being shown and designated as all of lot number one (1) on plat of property made for Fairview Baptist Church, by H.L. Dunahoo, surveyor, dated October 26, 1949, recorded in plat book "T" page 174, Greenville County R.H.C. Office and having the following metes and bounds, according to said plat to-wit:
