



"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, City of Greenville, shown as Lot 368 on plat of Section B-1, Gower Estates, recorded in Plat Book XX at page 107 and having, according to said plat, the following courses and distances:

BEGINNING at an iron pin on Hialeah Road, joint front corner of Lots 367 and 368 and running thence along the joint line of said lots, N. 69-08 E. 133.1 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 368, N. 2-55 E. 100 feet to an iron pin, joint rear corner of Lots 368 and 369; thence with the joint line of said lots, S. 87-25 E. 171.5 feet to an iron pin on Hialeah Road; thence with said Road, S. 14-32 W. 75 feet and S. 25-49 W. 75 feet to the point of beginning.
