

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Sumny Lane, being shown and designated as a portion of Tract 6A, Block 3, page 276 of the County Block Book and more particularly described follows:

BEGINNING at the Northeastern corner of tract above described and running thence N. 19-45 E. 39.1 feet to sweet gum; thence S. 89 E. 60 feet crossing branch to stone; thence N. 21-15 E. 193 feet again crossing branch to corner of other lands now or formerly owned by John T. Gilbert; thence S. 86-46 W. 234 feet to pin; thence S. 21-20 W. 100 feet; thence S. 18-36 E. 92 feet to pin at northwestern corner of the tract of land first above described; thence with the line of said tract, S. 74 E. 107.6 feet to the point of beginning.
