All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Creenville, on the Southern side of Amy Lane, being shown and designated as Lot No. 218 on plat entitled Sheet One, Section Six, Colonial Hills, made by Piedmont Engineers & Architects, dated March 21, 1968, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WWW at Page 12, and having, according to said plat the following metes and bounds-to-wit:

BEGINNING at an iron pin on the South side of Amy Lane at the joint corner of Lots 217 and 218 and runs thence along the line of Lot 217 U.S. 4-42 E. 183.5 feet to an iron pin; thence S. 74-01 E. 110 feet to an iron pin; thence N. 73-31 E. 25.6 feet to an iron pin; thence Palong the line of Lot 219 N. 11-45 W. 231.3 feet to an iron pin on the South side of Amy Lane; thence along Amy Lane S. 78-20 W. 100 feet to the beginning corner.

"In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less.
