



NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, at the southeastern corner of the intersection of Manchester Drive with Archdale Drive, being shown and designated as Lot No. 57 on a plat of MONTCLAIRE, SECTION 4, made by R. B. Bruce, Surveyor, dated October 24, 1970, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book 4-F at page 49, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Archdale Drive at the joint front corners of Lots Nos. 56 and 57, and running thence with Archdale Drive, N. 29-18 E., 85.3 feet to a point; thence with the curve of the intersection of Archdale Drive, with Manchester Drive, the chord of which is N. 76-35 E., 34.6 feet to an iron pin; thence along the southern side of Manchester Drive, S. 58-00 E., 145.1 feet to an iron pin; thence S. 29-18 W., 105.4 feet to an iron pin at the joint rear corners of Lots Nos. 56 and 57; thence with the common line of said lots, N. 60-42 W., 170 feet to an iron pin, the point of BEGINNING.
