All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 185 on plat of Forrester Woods, Section IV, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R, at page 68 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Royal Oak Road, joint corner of Lots 184 and 185, and running thence along the common line of said lots S. 14-50 E. 110 feet to a point, joint corner of Lots 185 and 186; thence with the common line of said lots, N. 64-59 E. 186.6 feet to a point on Royal Oak Court; thence with the line of said Court N. 20-50 W. 75 feet to a point; thence N. 65-25 W. 35.6 feet to a point on Royal Oak Road; thence with said Road S. 70-0 W. 75 feet to a point; thence continuing with said Road S. 64-45 W. 75 feet to the point of beginning.
