All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the northerly side of Redbud Lane, near the City of Greenville, South Carolina, and being designated as Lot No. 58 on plat entitled "Green Valley Estates" as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, Page 2 and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Redbud Lane, joint front corner of Lots 58 and 59 and running thence along the common line of said lots N. 11-22 W. 291.2 feet to an iron pin on the edge of golf course; thence N. 85-05 E. 192.2 feet to an iron pin, joint rear corner of Lots 57 and 58; thence along the common line of said lots S. 17-19 E. 257.7 feet to an iron pin on the northerly side of Redbud Lane; thence along said Lane S. 76-38 W. 120 feet; thence continuing with said Lane S. 83-41 W. 100 feet to an iron pin, the point of beginning.
