TO ALL WHOM THESE PRESENTS MAY CONCERN: THOMAS S. COUTURE and

CHRISTINA A. COUTURE (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-one Thousand and No/100-----DOLLARS

(\$ 41,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 63 of a subdivision known as River Downs according to a plat thereof dated July 17, 1974 and recorded in the RMC Office for Greenville County in Plat Book 4-R at Pages 75 and 76, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Suffolk Court, joint front corner of Lots 63 and 64; running thence with the joint line of said Lots, N. 61-20 E. 205 feet to an iron pin in the line of Lot 42; thence with the line of Lot 42, S. 51-15 E. 79.21 feet to an iron pin at the joint rear corner of Lots 62 and 63; running thence with the joint line of said Lots, S. 48-00 W. 230 feet to an iron pin on the eastern side of Suffolk Court, joint front corner of Lots 62 and 63; thence with the eastern side of Suffolk Court to the following metes and bounds, to-wit: N. 40-57 W. 102 feet to an iron pin and N. 7-49 W. 28.33 feet to the point of beginning.
