WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

--Thirty Three Thousand, Eight Hundred and No/100----- DOLLARS

(\$ 33,800.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

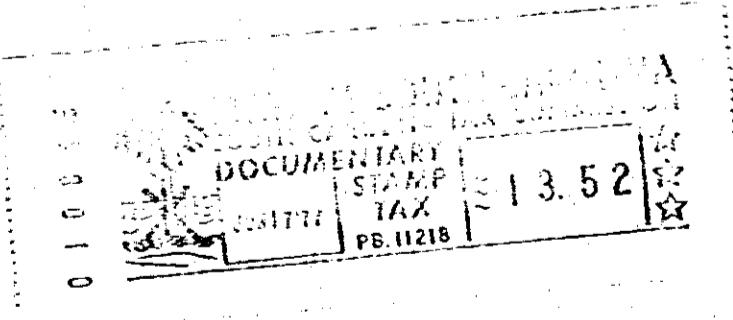
All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southeastern side of Pimlico Road, being known and designated as Lot 84 as shown on plat of Section A, Gower Estates made by Dalton & Neves, Engineers dated January, 1960 and recorded in the RMC Office for Greenville County in Plat Book QQ at Pages 146 and 147 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Pimlico Road at the joint front corner of Lots 83 and 84 and running thence along line of Lot 83 S. 76-41 E. 175 feet to an iron pin; running thence S. 13-19 W. 96.8 feet to an iron pin; thence with the line of Lot 85 N. 76-41 W. 175 feet to an iron pin on the southeastern side of Pimlico Road; thence with Pimlico Road N. 13-19 E. 96.8 feet to the point of BEGINNING.
