NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

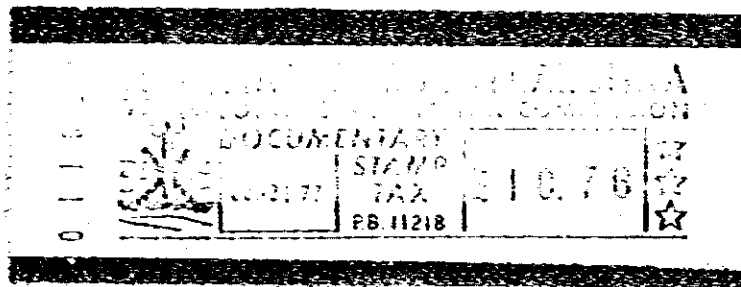
"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Simpsonville, situate on the east side of Cheyenne Drive, Austin Township, being shown as Lot 70 on Plat of Section I of WESTWOOD Subdivision, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-F at page 21, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the east side of Cheyenne Drive at the joint front corner of Lots 69 and 70 and runs thence along the line of Lot 69 S. 89-40 E. 150 feet to an iron pin; thence N. 0-11 E. 100 feet to an iron pin; thence along the line of Lot 71 N. 89-40 W. 150 feet to an iron pin on the east side of Cheyenne Drive; thence along Cheyenne Drive S. 0-11 W. 100 feet to the beginning corner.
