All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Gail Drive and being known and designated as lot 43 on a plat of Section Five, Knollwood Heights, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4R at Pages 91 and 92 and having, according to said plat, the following metes and bounds:

BEGINNING at a point on the southern edge of Gail Drive at the joint front corner of lots 43 and 44 and running thence along a line of lot 44, S. 02-10-28 E., 200.0 feet to a point; thence N. 85-00-34 W., 105.83 feet to a point; thence along a line of lot 42, N. 02-10-28 W., 186.80 feet to a point on the southern edge of Gail Drive; thence along the southern edge of said drive, N. 87-49-32 E., 105.0 feet to the beginning corner.
