

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, at the southeast corner of Merrilat Drive and Earnshaw Avenue, beginning known and designated as Lot NO. 114 on a plat 3 of Sans Souci Heights subdivision recorded in Plat Book 2 at Page 95 of the R.M.C.Office for Greenville County, S. 


