MODIFICATION & ASSUMPTION AGREEMENT

WHEREAS Fidelity Federal Savings and Loan Association of Greenville, South Carolina, hereinafter referred to as the ASSOCIATION, is the owner and holder of a promissory note dated December 15, 1965, executed by H. J. Martin and Joe O. Charing in the original sum of \$ 9,000.00 bearing interest at the rate of 6 % and secured by a first mortgage on the premises being known as Lot No. 4 Bradley Boulevard, Greenville, South Carolina, which is recorded in the RMC office for Greenville County in Mortgage Book 1017, page 191, title to which property is now being transferred to the undersigned OBLIGOR(S), who has (have) agreed to assume said mortgage loan and to pay the balance due thereon; and

WHEREAS the ASSOCIATION has agreed to said transfer of ownership of the mortgaged premises to the OBLIGOR and his assumption of the mortgage loan, provided the interest rate on the balance due is increased from SIX (6) % to a present rate of Seven (7) %, and can be escalated as hereinafter stated.

NOW, THEREFORE, this agreement made and entered into this 30th day of June, 19 77, by and between the ASSOCIATION, as mortgagee, and Leslie H. Dean as assuming OBLIGOR,

WITNESSETH:

In consideration of the premises and the further sum of \$1.00 paid by the ASSOCIATION to the OBLIGOR, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

(1) That the loan balance at the time of this assumption is \$ 5,436.34; that the ASSOCIATION is presently increasing the interest rate on the balance to Seven (7) %. That the OBLIGOR agrees to repay said obligation in monthly installments of \$ 74.99 each with payments to be applied first to interest and then to remaining principal balance due from month to month with the first monthly payment being due July 1, 19 77.

(2) Should any installment payment become due for a period in excess of (15) fifteen days, the ASSOCIATION may collect a "LATE CHARGE" not to exceed an amount equal to five per centum (5%) of any such past due installment payment.

(3) That all terms and conditions as set out in the note and mortgage shall continue in full force, except as modified expressly by this Agreement.

(4) That this Agreement shall bind jointly and severally the successors and assigns of the ASSOCIATION and OBLIGOR, his heirs, successors and assigns.
