"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Easterly side of Foxcroft Road, being shown and designated as Lot No. 3 as shown on platentitled "Carter's Grove, Section I" prepared by Dalton & Neves, Engineers, dated August 1974, which plat is of record in the RMC Office for Greenville County, S. C., in Plat Book 4-R, at Page 99, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the Eastern side of Foxcroft Road at the joint front corner of Lots 3 and 4; running thence with the common line of said two lots, S. 68-27 E. 188.7 feet to an iron pin; thence along the rear line of Lot No. 3, N. 9-30 E. 91 feet to an iron pin; thence N. 9-30 E. 25.9 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with the common line of said lots N. 78-24 W. 170.7 feet to an iron pin on Foxcroft Road; thence along Foxcroft Road S. 19-13 W. 85 feet to the point of beginning.
