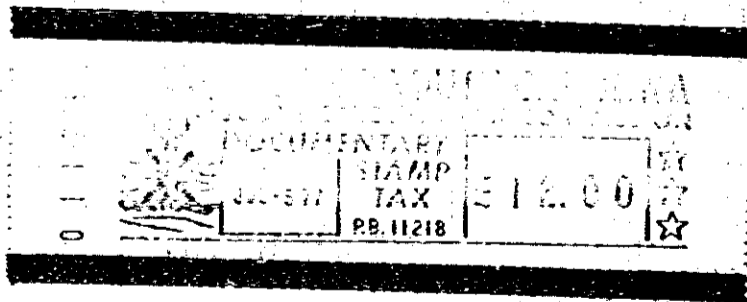

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, on the southeasterly side of Pimlico Road, being known and designated as Lot No. 81, Section A, Gower Estates, as recorded in the RMC Office for Greenville County, S. C. in plat book QQ at page 146 and 147, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeasterly side of Pimlico Road, said pin being the joint front corner of Lots 80 and 81 and running thence with the common line of said lots S. 76-41 E. 175 feet to an iron pin; thence S. 13-19 W. 90 feet to an iron pin on the northerly side of Carolina Avenue; thence with the northerly side of Carolina Avenue N. 76-41 W. 150 feet to an iron pin; thence with the curve of Carolina Avenue and Pimlico Road, the chord being N. 31-41 W. 35.4 feet to an iron pin on the southeasterly side of Pimlico Road; thence with the southeasterly side of Pimlico Road N. 13-19 E. 65 feet to an iron pin, the point of beginning.
