That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further 7 sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, near the City of Greenville, being on the southeast side of Rasor Drive, being shown as Lot No. 2 on plat of property of A. S. Campbell, made by W. J. Riddle, Surveyor, May 1947, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book Q, at Page 199, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Rasor Drive at joint front corner of Lots 1 and 2 and running thence with the line of Lot 1, S. 71-17 E., 247 feet to an iron pin; thence S. 18-43 W., 75 feet to an iron pin; thence with the line of Lot 3, N. 71-17 W., 247 feet to an iron pin on the southeast side of Rasor Drive; thence along the southeast Side of Rasor Drive, N. 18-43 E., 75 feet to the beginning corner.

This being the same property conveyed to Sara K. Gambrell by deed of Thomas Harrison Fetzer recorded in the RMC Office for Greenville County on January 13, 1955 in Deed Book 516 at Page 131. Sara K. Gambrell conveyed unto Earl Gambrell a one-half undivided interest in and to the said property by deed recorded in the RMC Office for Greenville County on March 13, 1972 in Deed Book 938 at Page 122.
