## CONSTRUCTION LOAN MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, REGENCY ENTERPRISES, INC.

Dollars (\$ 31,875.00 ) due and payable with interest thereon at the same rate as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the terms of said note and any agreement modifying it are incorporated herein by reference; and an additional sum in a like amount if advanced pursuant to the covenants herein, the note secured hereby or the construction loan agreement between mortgagor and mortgagee, the total of said sums being the maximum principal amount of this mortgage.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 16 on a plat entitled Westminister Village, Section I, prepared by Heaner Engr. Co., Inc. and recorded August 5, 1976 in Plat Book 5P at page 40 in the R.M.C. Office for Greenville County, S. C. and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Ambergate Court at the joint front corner of Lots Nos. 16 and 17 and running thence with the line of said lots N. 79-59 W. 144.13 feet to an iron pin at the joint rear corner of Lots Nos. 16 and 13; thence along the joint rear line of Lots Nos. 16 and 13 N.17-37 E. 100.52 feet to an iron pin at the joint rear corner of Lots Nos. 15 and 16; thence along the joint line of said lots S. 72-23 E. 140.47 feet to an iron pin on the western side of Ambergate Court; thence with the western side of said Court S. 16-07 W. 76.19 feet to an iron pin; thence continuing with said Court S. 13-04 E. 5.32 feet to the point of beginning.

This is the same property conveyed to the mortgagor herein by deed of Westminister Company, Inc. recorded July  $\frac{\lambda l}{R}$ , 1977 in the R.M.C. Office for Greenville County, S. C. in Deed Book 1969 at Page 932.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
