TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Joe D. Hollar and Rheta E. Hollar

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty Thousand Four Hundred and no/100-----

All that piece, parcel or lot of land situate, lying and being on the eastern side of Halloway Circle near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 43 of a sub-division known as Grandview Hills, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book XX at Pages 173, and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Halloway Circle at the joint front corner of Lots Nos. 46 and 43, running thence N. 81-31 E. 249.7 feet to an iron pin at the joint rear corner of Lots 43 and 48, running thence S. 25-32 E. 211.2 feet to an iron pin in the line of property now or formerly of Rosamond, running thence S. 76-33 W. 131.1 feet to an iron pin at the joint rear corner of Lots 43 and 42, running thence N. 57-50 W. 249.4 feet to an iron pin on the eastern side Of Halloway Circle, running thence with the eastern side of said Circle, N. 0-38 E. 50 feet to an iron pin, point of beginning.
