All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 37 on a plat of North Hampton Acres Subdivision, dated December, 1961, prepared by C. O. Riddle, recorded in Plat Book YY, at page 63 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Milbrook Circle at the joint front corner of Lots 29 and 37 and running thence with Milbrook Circle, N. 76-55 W. 186 feet to an iron pin; thence still with said Circle, N. 60-08 W. 75 feet to an iron pin; thence still with said Circle, N. 24-45 W. 74.5 feet to an iron pin; thence N. 7-56 W. 78 feet to an iron pin at the joint front corner of Lots 36 and 37; thence with Lot 36, N. 82-04 E. 260 feet to an iron pin at the joint rear corner of Lot 36 and 37; thence with Lot 29, S. 6-44 E. 261.9 feet to the point of beginning and containing 1.22 acres.
