WHEREAS: JONATHAN B. FLOYD AND LINDA B. FLOYD

Greenville County, South Carolina, hereinafter called the Mortgagor, is indebted to

NORTH CAROLINA NATIONAL BANK, a corporation organized and existing under the laws of United States, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of ----- TWENTY-TWO THOUSAND NINE HUNDRED & 00/100----- Dollars (\$ 22,900.00 ), with interest from date at the rate of EIGHT & ONE-HALF per centum ( 8½ %) per annum until paid, said principal and interest being payable at the office of NCNB MORTGAGE CORPORATION in Charlotte, North Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of ----- ONE HUNDRED SEVENTY-SIX & 10/100----- Dollars (\$ 176.10 ), commencing on the first day of OCTOBER, 19 77, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of SEPTEMBER, 2007.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Town of Fountain Inn and being shown on plat of property prepared for Jonathan B. Floyd and Linda B. Floyd by J. L. Montgomery, III, R.L.S., dated July 19, 1977, to be recorded in the R.M.C. Office for Greenville County in Plat Book \_\_\_\_\_, Page \_\_\_\_\_, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin in the northwestern edge of Fairview Street, joint corner with property now or formerly of Holland and running thence N. 61-06 W., 280 feet to an iron pin; thence turning and running N. 52-08 E., 137.32 feet to an iron pin; thence turning and running S. 60-13 E., 148.25 feet to an iron pin; thence running S. 58-51 E., 130.2 feet to an iron pin in the northwestern edge of Fairview Street; thence turning and running along Fairview Street, S. 52-45 W., 129.87 feet to an iron pin, the point of beginning.
