MORTGAGE

STATE OF SOUTH CAROLINA
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: GERALD L. AND JEAN G. STRAUCH

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY FIVE THOUSAND SEVEN HUNDRED TWENTY THREE AND 77/100----- DOLLARS

(\$ 25,723.77), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 24 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

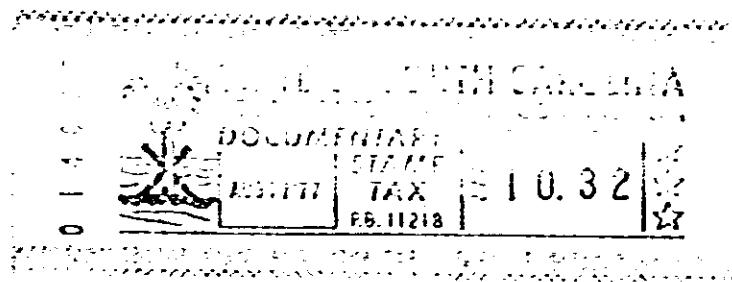
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the easterly side of Castlewood Drive, near the City of Greenville, being known and designated as Lot No. 54 on plat entitled "Find Plat Revised Map No. 2, Foxcroft Section II," as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4N, at pages 36 and 37, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Castlewood Drive said pin being the joint front corner of Lots 54 and 55 and running thence with the common line of said lots S. 56-51 E., 160.8 feet to an iron pin joint rear corner of Lots 54 and 55; thence S. 41-51 W., 154.6 feet to an iron pin, the joint rear corner of Lots 54 and 54, thence with the common line of said lots N. 44-31 W., 165.6 feet to an iron pin on the southeasterly side of Castlewood Drive, thence with the southeasterly side of Castlewood Drive N. 46-01 E., 40 feet to an iron pin, thence continuing with said Drive N. 43-39 E., 80 feet to an iron pin, the point of beginning.

This is the identical property conveyed to the mortgagors by deed of Robert M. and June S. Powell to be recorded of even date herewith.
