"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel or lot of land situate, lying and being on Churchill Circle near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 90 of a subdivision known as Augusta Acres, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book S at page 201, said lot having such metes and bounds as shown thereon.
