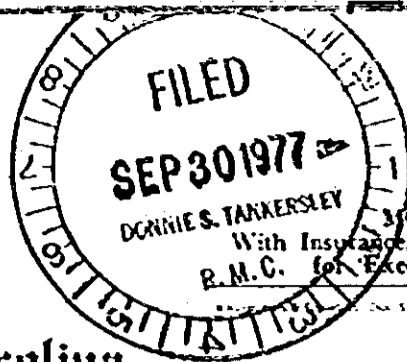

Jones and Irene Jones in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Domestic Loans of Greenville, Inc.

The following described property being real estate situate in the county of Greenville, State of South Carolina.

All that piece, parcel or lots of land situated in the county of Greenville, State of South Carolina, on the Northwestern corner of the intersection of Kennedy and Cashmer Drives and being known and designated as Lot No. 101 of Pine Hill Village as shown on plat thereof recorded in the RMC Office for Greenville County, S.C., in Plat Book "QQ" at page 169 and having according to said plat; the following metes and bounds to-wit:

Beginning at an iron pin on the northern side of Kennedy Drive at the joint corner of Lots Nos., 101 and 102 running thence along the joint line of said lots, N. 29-22 E. 73.7 feet to an iron pin; thence along the joint line of Lots No. 100 and 101 S. 86-45 E. 92 feet to an iron pin; thence along the western side of Cashmere Drive S. 3-15 W. 78 feet to an iron pin; thence with the curb of the intersection of Cashmere and Kennedy Drives, N. 69-48 W. 98.4 feet to an iron pin; N. 60-38 W. 9.3 feet to the point of beginning.
