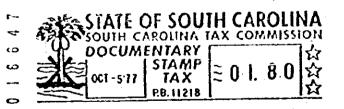
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollurs (\$5.60) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in Highland Township, containing 2.56 acres according to a plat of the property of Otto & Linda Painter made by Terry T. Dill, September 23, 1977, said plat being recorded in the RMC Office for Greenville County in Plat Book 6I, page 5I and having the following metes and bounds:

BEGINNING at an iron pin at old corner of Lee property and the 2.56 acres and running thence N. 02-51 W. 132 feet to iron pin in edge of right of way extending from Highway 25 for 25 feet in width and running thence N. 77-52 E. 836 feet to Neal Creek; running thence with Neal Creek as the line, S. 19-00 E. 132 feet to iron pin; running thence along Lee line, S. 77-52 W. 873 feet to old corner, the beginning corner.

Together with easement for ingress as shown in deed conveyed this date to Mortgagors by Mortgagee .

Together with all and singular rights, members, hereditaments, and apputtenances to the same belonging in any way incident or appertuning, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumling, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manners it being the intents not the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided begin. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
