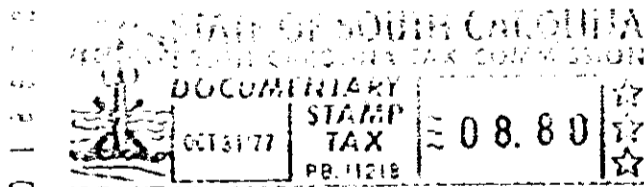
THIS MORTGAGE is made this 25th day of October 19. 77., between the Mortgagor... Fontanelle. Austin. Burdette... (herein "Borrower"), and the Mortgagee, WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of the United States of America, whose address is 206 South Main Street, Woodruff, S. C. 29388 (herein "Lender").

Greenville... State of South Carolina: All that piece, parcel or lot of land lying, being and situate on the Southwest side of Ponderosa Drive about 1 1/2 miles East of the Town of Simpsonville, in Greenville County, State of South Carolina, containing One and 20/100 (1.20) acres, more or less, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the Southwest side of said drive and running thence S.67-30 W.290 feet to an Iron Pin, thence N.31-49 W.235 feet to an Iron Pin, thence N.80-20 E. 242.8 feet to an Iron Pin on the Southwest side of Ponderosa Drive, thence with the Southwest side of Ponderosa Drive S.49-40 E.200 feet to the beginning point. This being a part of the property which was conveyed to Wilton W. Mayfield by Lottie Thackston by deed recorded in the R. M. C. Office for said County on March 29, 1940 in Deed Book 219, page 358. And this being the same property which was conveyed to mortgagor herein by Wilton W. Mayfield by deed which will be recorded forthwith in said office. To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
