In Forty-Eight (48) consecutive monthly installments of Three Hundred Fifty-Nine and 40/100 (\$359.40) dollars, beginning December 23, 1977 and on the same day of each month thereafter until paid in full

with interest thereoff from November 23, 1977 at the rate of 14.00 per centum per around, to be good

WHEREAS, the Mortgagor may bereafter become indebted to the said Mortgagoe for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance prendums, public assessments, repairs, or for any other purposes.

NOW, ENOW ALL MEN, That the Mortgagor, an consideration of the aforesaid debt, and an order to secure the pasment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also an consideration of the further sum of Three Dollars (\$3.49) to the Mortgagor in hand well and cruly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, histgained, sold and released, and by these presents does grant, hargain, sell and release unto the Mortgagoe, its successors and assigns

All that certain piece, parcel or lot of land situate, lying and being on the west side of Brunswick Avenue in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 13 on a plat of the property of Harry H. Palm recorded in the RMC Office for Greenville County in Plat Book "B" at Page 84, reference to said plat being hereby craved for a metes and bounds description.

ALSO, all that certain piece, parcel or lot of land situate in Greenville Township, Greenville County, State of South Carolina, on the western side of Poplar Drive (also known as Brunswick Avenue), being known and designated as the rear portion of Lot No. 14, as shown on a Plat of Property of Harry H. Palm, made by W. J. Riddle, Surveyor, in May, 1945, and recorded in the RMC Office for Greenville County in Plat Book "B at Page 84, reference to said plat being hereby craved for a metes and bounds description.

Lot 13 is the same property conveyed to mortgagor herein by deed of Gene F. Lyda recorded December 30, 1968 in the RMC Office for Greenville County in Deed Book 858 at Page 469.

Lot 14 is the same property conveyed to mortgagor herein by deed of William Duncan recorded November 14, 1972 in the RMC Office for Greenville County in Deed Book 960 at Page 352.

Together with all and singular rights, members, hereditaments, and appurerances to the same belonging in any way medical or appertaining, and all of the rests, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any mattier, it being the internion of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its horts, successors and assigns, forever

The Mortgagor covenants that it is lawfully seized of the premises bereinabline described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are tree and clear of all hers and encumbrances except as provided berein. The Mortgagor further coverants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully elaiming the same or any part thereof

The Mortgagor further coveriants and agrees as follows

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the opision of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the coveriants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortagee unless otherwise provided in writing.

(2) That it will keep the improvements now existing or bereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.

(3) That it will keep all improvements now existing or hereafter erected in pood repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
