(\$ 40,350.00 . . .), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Thirty(30)—years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, bying and being in the State of South Carolina, County of Creenville. Town of Simpsonville, on the northwestern side of Delmar Drive, being shown and designated as Lot No. 31 on a plat of BRENTWOOD, Section 2, made by Piedmont Engineers and Architects, dated May 19, 1972, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at Page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGNNNING at an iron pin on the northwestern side of Delmar Drive, corner of Lots 30 and 31 and running thence N. 77-45 W. 162.3 feet to an iron pin; thence along the rear lot line N. 6-58 W. 72.8 feet to an iron pin; thence along the joint property line of Lots 31 and 32, N. 59-41 E. 150.77 feet to an iron pin; thence along Delmar Drive S. 20-35 E. 102.6 feet; thence continuing along the curve of Delmar Drive, S. 0-50 E. 87.0 feet to the point of beginning.

This property is conveyed subject to all restrictions, easements, and zoning ordinances of record or on the ground affecting said property.

ODERIVATION: This is that same property conveyed to Hamir D. Merchant and Kathryn E. Herchant by deed of Rufus V. Roberds and Ida R. Roberds dated and recorded concurrently herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgager promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the mprincipal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgage may advance this premium and collect it as part of the debt secured by the mortgage if the Omortgagor fails to pay it.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, he considered a part of the real estate.
