conditions), said note to be repaid with interest as the rate or rates therein specified in installments of . Two Hundred

Eighty-Nine and 67/100 ------ (\$ 289.67) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest computed monthly on inqual principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and suspaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortengee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortesgee may hereafter become included to the Mortesgee for such further sums as may be advanced to the Mortesgee's account for the payment of taxes, increases premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's assessme, and also in consideration of the sum of Three Deliars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is bracky advanced deed, has granted, longanied, sold, and released, and by these presents does grant, longain, sell and release unto the Mortgagor its successors and assigns, the following described real estate:

All that certain piece, parcel, or let of land, with all improvements thereon, or hereafter to be constructed thereon, shune, bing and lengt in the State of South Cardina, County of GreenVIIIe, being known and designated as Lot No. 25 of a sub-division known as Meadowood, according to a plat thereof prepared by C.O. Riddle, dated August 27, 1971, and recorded in the RMC Office for Greenville County in Plat Book 4-N at Page 25, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Woodgreen Drive at the joint front corner of Lots 24 and 25 and running thence with the sjoint line of said Lots, N 54-43 E. 160 feet to an iron pin at the joint Prear corner of Lots 24 and 25; running thence with the rear line of Lot 25, S. 35-17 E 100 feet to an iron pin at the joint rear corner of Lots 25 and 26; thence along the joint line of said Lots, S. 54-43W. 160 feet to an iron pin on the northeastern side of Woodgreen Drive at the joint Ifront corner of Lots 25 and 26; thence along the northeastern side of Woodgreen Drive, N. 35-17 W. 100 feet to the point of beginning.
