This gramed, bargained, sold and release unto the Mortgager, its successors and assigns:

being in the State of South Carolina, County of GREENVILLE, on Sullivan Road being shown and designated as 2.45 acres, more or less, and being more particularly described in accordance with a plat entitled "Property of Lonnie R. & Julia A. Collins" dated November 17, 1977, and prepared by C. O. Riddle, RLS, to-wit:

BEGINNING at a point in the center of Sullivan Road, said point being the joint corner with the property of Masters and running thence along the center of Sullivan Road N. 25-30-32 W. 425 feet to a spike in the center of Sullivan Road; thence leaving Sullivan Road and running along the joint property line of Sue C.
