NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of Pendleton road, near the City of Greenville, and being shown on plat recorded in PMC Office in Plat Book E, at page 279, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Pendleton Road, joint corner with property now or formerly owned by I. J. Seyle, and running thence with the Northern side of Pendleton Road N. 80-04 E. 80.7 feet to corner of Property formerly owned by Farmers Loan & Trust Co.; thence with the line of said property N. 10-03 E. 124.5 feet to an iron pin; thence continuing with the line of said property N. 45-35 W. 79.5 feet to an iron pin in line of property formerly owned by I. J. Seyle; thence with the line of said property S. 11-09 E. 181.9 feet to the point of beginning. Said premises being the same conveyed to the grantor by I. J. Seyle, by deed recorded in Volume 69 at page 162.
