(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Five Thousand and No/100

DOLLARS

(\$ 25,000.00) as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is fifteen (15) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the westerly side of White Horse Road, being shown and designated as a portion of Westwood Plaza on plat of Property of Paul W. Fulbright and Sylvia Fulbright, prepared by Freeland & Associates, Engineers, November 2, 1977, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the westerly side of White Horse Road at corner of property herein described and property of Rice Corporation, said point being 250 feet, more or less, south of Broadway Drive, and running thence with the westerly side of White Horse Road, S. 26-38 E. 35 feet to a point; running thence S. 69-20 W. 206.9 feet to a point; running thence N. 80-21 W. 160.54 feet to a point; thence N. 18-48 E. 40.52 feet to a point; thence with property of Rice Corporation, S. 80-21 E. 154.1 feet to a point and N. 69-15 E. 183.1 feet to the point of BEGINNING.
