That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 86 on plat of Berea Forest, Section 2, recorded in Plat Book 4 N at pages 76 and 77 and having the following courses and distances:

BEGINNING at an iron pin on Berea Forest Circle, joint front corner of Lots 86 and 87 and running thence with joint line of said lots, N. 60-55 E. 130 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 86, S. 29-05 E. 90 feet to an iron pin; thence with joint lines of Lots 86 and 85, S. 60-55 W. 130 feet to an iron pin on Berea Forest Circle; thence with said Circle, N. 29-05 W. 90 feet to the point of beginning.
