David Lee Wilson and Alene L. Wilson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-One Thousand Three Hundred and No/100----- DOLLARS

(\$ 41,300.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 116 on the eastern side of Great Glen Road on plat entitled Del Norte Estates, recorded in Plat Book WW at page 33 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Great Glen Road at the joint front corner of Lots 116 and 117 and running thence with the line of Lot 117 S. 71-59 E. 123.4 feet to an iron pin in the line of Lot 118; thence with the line of Lot 118 S. 18-03 W. 60.5 feet to an iron pin at the rear corner of Lot 114; thence with the line of Lot 114 S. 19-11 W. 67.5 feet to an iron pin at the corner of Lot 115; thence with the line of Lot 115 N. 72-54 W. 124.9 feet to an iron pin on the eastern side of Great Glen Road; thence with the eastern side of said road N. 19-17 E. 130 feet to the beginning corner.

THIS property is conveyed subject to restrictions recorded in Deed Book 858, Page 451 and also subject to 10 foot drainage easement as shown on recorded plat and all other easements of record and on the grounds which affect said property plus any zoning ordinances.

THIS is the same property conveyed to the mortgagors herein by deed of Alfred N. Bell and Carol G. Bell as recorded in the RMC Office for Greenville County, S.C. in Deed Book 1072 at Page 915 on February 1, 1978.

"In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
