TO ALL WHOM THESE PRESENTS MAY CONCERN: Joseph Fred Tompkins and

Frances D. Tompkins,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eleven Thousand and 00/100-----DOLLARS

(\$11,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the southeastern side of Clemson Avenue, being known and designated as a portion of Lot #3 on plat of property of H. H. & Alice M. Willis, which plat is recorded in the RMC Office for Greenville County in Plat Book J-150 & 151, (see also Plat Book K-271), and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Clemson Avenue at the joint corner of Lots 2 & 3, and running thence along line of Lots 1 & 2, S. 74-15 E. 190.0 feet to an iron pin at the joint rear corner of Lots 1 & 3; thence S. 35-05 W. 100.0 feet to an iron pin; thence a new line through Lot #3, N. 54-52 W. 188.2 feet to an iron pin on the southeastern side of Clemson Avenue; thence along said Clemson Avenue, N. 48-40 E. 38.0 feet to the beginning corner.

This being the same property conveyed to the Mortgagors herein by Deed of Frances Duckworth Burgess, which Deed was recorded on November 22, 1963, in the RMC Office for Greenville County in Deed Book 736-567.
