ALL that certain piece, parcel or tract of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 1.61 acres, more or less, on the southwestern curve of Milbrook Circle, being shown and designated as Lot No. 33 on a Map of North Hampton Acres made by C. O. Riddle, Surveyor, dated December 1961 recorded in the RMC Office for Greenville County, South Carolina, in Plat Book YY at page 63, reference to which plat is hereby craved for the metes and bounds thereof.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the hyment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also securenthe Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long of the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the nortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
