"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Devonshire Lane being shown and designated as Lot No. 32 on Plat of Northwood Hills, Section 1, dated December 1959 prepared by Piedmont Engineers, recorded in Plat Book RR at Page 15 and being described, according to said Plat, more particularly, to-wit:

BEGINNING at an iron pin on the northern side of Devonshire Lane at the joint front corner of Lots 32 and 33 and running thence along the common line of said lots N. 17-42 W. 177.2 feet to an iron pin at the joint rear corner of said lots; thence S. 81-30 E. 140 feet to an iron pin at the joint rear corner of Lots 31 and 32; thence along the common line of said lots S. 14-25 E. 110 feet to an iron pin at the joint front corner of said lots on the northern side of Devonshire Lane; thence along the northern side of Devonshire Lane S. 70-00 W. 130 feet to an iron pin, the point of beginning.
