'All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, known and designated as Lot 65 of Western Hills as shown on plat in Plat Book QQ at pages 98 and 99, and being described accordingly by a survey and plat of C. C. Jones, dated June 24, 1961, as follows:

BEGINNING at an iron pin on the northern side of Tucson Drive at corner of Lot 64, and running thence with line of said lot N. 21-43 W., 153 feet to iron pin; thence S. 78-44 W., 11.6 feet to a stake; thence S. 68-4 W., 100.9 feet to a stake in line of Lot 66, thence with line of said lot S. 26-08 E., 162.6 feet to iron pin on Tucson Drive; thence with said drive N. 63-17 E., 24.5 feet to a stake; thence with said drive, N. 65-17 E., 75.5 feet to the beginning.
