THE REPORT OF THE PROPERTY OF

- (1) That this mortgage shall secure the Mortgage for such further sums as may be advanced hereafter, at the option of the Mortgage, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
