The mortgagor will keep the buildings on said premises insured against loss by fire with the policy or policies of insurance to provide for extended coverage in companies and amounts satisfactory to and with a mortgagee clause making payments for loss under a local class of insurance obsering the premises payable to the mortgagee and deliver the policies marked in a little mortgagee and renewals thereof at least seven days before the expiration of the old policies.
