conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Three Hundred

Forty-Three and 59/100----- 343.59) Dollars each on the first day of each

month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed insuffly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date: and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereinder shall be past due and inpuid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole anount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Woodharbor Drive and being known and designated as Lot No. 4 of WOODHARBOR Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book 5-P at Page 37, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an ironpin on the southwestern side of Woodharbor Drive at the joint front corner of Lots 3 and 4 and running thence with the joint line of said Lots, S.39-13 W. 198.7 feet to an iron pin; running thence N.51-08 W. 97 feet to an iron pin to an iron pin at the joint rear corner of Lots 4 and 5; running thence with the joint line of said Lots, N.39-13 E. 199.2 feet to an iron pin on the southwestern side of Woodharbor Drive; running thence with the southwestern side of said Drive, S.50-48 E. 97 feet to an iron pin, point of beginning.
