TO ALL WHOM THESE PRESENTS MAY CONCERN: WILLIAM F. CARROLL

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FIFTEEN THOUSAND, FIVE HUNDRED & 00/100..... DOLLARS

(\$15,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lots 51 and 52, as shown on a plot of the subdivision of Anderson Street Highlands, recorded in the Office of the R.M.C. for Greenville County, in Plat Book "J", Page 157, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North East side of East Welborn Street at the joint corner of lots 52 and 53, which joint corner is 712.5 feet from the South East corner of Anderson Road, and running thence along the line of said lot 52, North 42-40 East, 150 feet to an iron pin; thence South 47-20 East 100 feet to an iron pin at the rear corner of Lot No. 50; thence along the line of Lot No. 50, South 42-20 West 150 feet to an iron pin on the Northeast side of East Welborn Street; thence along the Northeast side of East Welborn Street, North 47-20 West 100 feet to the beginning corner.

This is the same property conveyed to the Mortgagor herein by deed of James William Jordon dated April 21, 1978, and recorded in the R.M.C. Office for Greenville County, South Carolina in Deed Book 1017 at Page 535.
