TO ALL WHOM THESE PRESENTS MAY CONCERN:

Premier Investment Co., Inc. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-six Thousand and no/100----- DOLLARS

(\$ 46,000.00---), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-nine years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 84 on plat of Devenger Place, Section 3, recorded in the RMC Office for Greenville County in Plat Book 5P at page 99, and having the following metes and bounds:

Beginning at an iron pin on Hedgewood Terrace (Abbey Terrace), joint front corner of Lots 84 and 85; thence with said Street, S 85-42 E 70 feet to an iron pin and N 87-38 E 20 feet to an iron pin at corner of Lot 14; thence with line of Lot 14, N 13-43 W 155.3 feet to an iron pin; thence N 85-42 W 50 feet to an iron pin at joint rear corner of Lots 84 and 85; thence with line of Lot 85, S 1-11 W 150.22 feet to the beginning corner.
