ALL that piece, parcel or bt of land situate in the County of Greenville, State of South Carolina, in the City of Greer, S. C., on the western side of Caldwell Street and being known and designated as Lot No. 51 on Plat of Property of Mrs. Geanie Caldwell recorded in the R.M.C. Office for Greenville County, S.
