Richard H. Britton and Jane H. Britton



KNOW ALL MEN, that the said mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the condition of the said note, and also in consideration of the further sum ONE DOLLAR, to the said mortgagor in hand well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presence do grant, bargain, sell and release unto the said mortgagee:

All that certain piece, parcel or unit, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Unit No. 187 of Inglewood Horizontal Property Regime as is more fully described in Master Deed dated October 1, 1974, and recorded in the RHC Office for Greenville County in Deed Vol. 1008, at page 69 and survey and plot plan recorded in Plat Book 5F at page 79.

This being the same property conveyed to Richard H. Britton and Jane H. Britton by Redmond-Huguenin Enterprises, a limited partnership, by deed dated Harch 14, 1977, and recorded on Harch 16, 1977, in Deed Book 1052, Page 790, RHC Office Greenville County



TOGETHER with the improvements thereon and the rights and appurtenances thereto belonging or appertaining. The and and improvements are hereinafter referred to as the "property".

SUBJECT to a prior mortgage dated Har. 14, 1977, and recorded in the Office of the Register of Mesne Conveyance (Clerk of Court) of Greenville County in Mortgage Book 1391, page 769.

TO HAVE AND TO HOLD all and singular the said premises unto the said mortgagee, its successors and assigns forever, and the mortgagor hereby binds himself, his successors, heirs, executors, administrators and assigns to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors and assigns, from and against himself, his successors, heirs, executors, administrators and assigns, and all other persons whomsoever lawfully claiming or to claim the same or any part thereof.

PROVIDED, that the Mortgagor shall well and truly pay or cause to be paid the Mortgage Debt hereby secured when and as the same shall become due and payable according to the tenor of the said Note and shall perform all the covenants therein on the Mortgagor's part to be performed, then this Mortgage shall be void.
