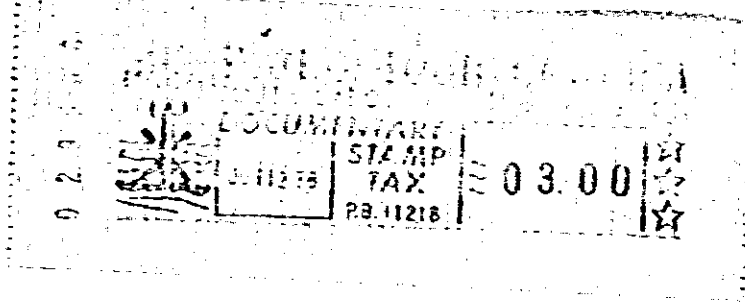
TO ALL WHOM THESE PRESENTS MAY CONCERN: William Ratliff Jr. and Louise Ratliff

of the county of Greenville, State of South Carolina, hereinafter called the Mortgagors, send greeting:
