TO ALL WHOM THESE PRESENTS MAY CONCERN: WALTER B. MEBANE and JONNIE ANN

MEBANE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Thirty-five Thousand Nine Hundred and no/100ths** ----- **DOLLARS**

(\$ 35,900.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **30** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

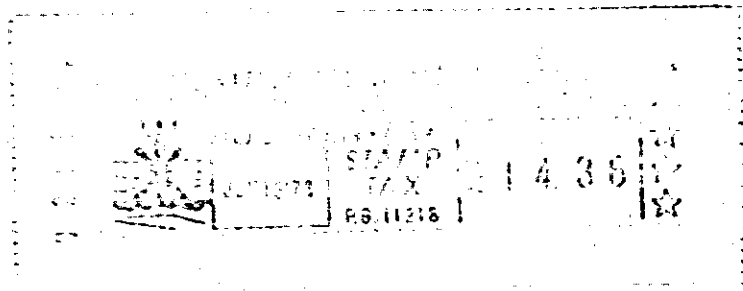

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Olde Orchard Lane, being known and designated as Lot No. 178 on a plat of COACH HILLS, made by Piedmont Engineers, Architects and Planners, dated September 26, 1974, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-X, at pages 85 and 86, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Olde Orchard Lane at the joint front corner of Lots Nos. 178 and 179 and running thence along the common line of said lots, S. 3-07 E., 150 feet to an iron pin; thence S. 86-54 W., 100 feet to an iron pin at the joint rear corner of Lots Nos. 177 and 178; thence with the common line of said lots, N. 3-05 W., 150.0 feet to an iron pin on the southern side of Olde Orchard Lane; thence along the southern side of Olde Orchard Lane, N. 86-53 E., 100.00 feet to an iron pin, the point of beginning.

The above property is the same conveyed to the Mortgagors by deed of Don Allen and Suzanne S. Allen to be recorded simultaneously herewith.
