BEGINNING at an iron pin on the eastern side of Rising Sun Court, joint front corner of Lots 26 and 27 and running thence along the common line of said Lots, S.79-51 E. 146.2 feet to an iron pin; running thence S.06-21 W. 100 feet to an iron pin, joint rear corner of Lots 27 and 28; running thence along the common line of said Lots, N.74-28 W. 160.6 feet to an iron pin on the eastern side of Rising Sun Court; running thence with the eastern side of Rising Sun Court, N.14-58 E. 85 feet to the point of beginning.
